ORDER:

In the Government Order third read above, the Government declared its intention to add certain villages in non-plan area and villages covered under Kurichi New Town Development Authority, to Coimbatore Local Planning Authority, under clause (b) of sub-section (1) of section 10 of the Tamil Nadu Town and Country Planning Act, 1971 (Tamil Nadu Act 35 of 1972).

2. In the letter fourth read above, the Director of Town and Country Planning has now stated that no new villages are added with the composite Local Planning Areas of Coimbatore declared under section 10(1)(b) of Tamil Nadu Town and Country Planning Act, 1971 and only the number and spelling mistakes in the village names are corrected. Therefore, the Commissioner of Town and Country Planning has requested the Government to issue Notification under sub-section (4) of section 10 of the said Act for confirmation of areas included in the Coimbatore Local Planning Area.

3. The Government, after careful examination, accept the proposal of the Commissioner of Town and Country Planning in para 2 above. Accordingly, the Government declare the area specified in the Notification appended to this order, to be the Coimbatore Local Planning Area.

4. Accordingly, the appended Notification shall be published in the next issue of Tamil Nadu Government Gazette.

5. The Collector of Coimbatore District is requested to republish the Notification both in English and Tamil in the District Gazette.

6. The Director of Translation, Chennai-9 is directed to arrange to have the Notification translated into Tamil and to forward the translation urgently to the Works Manager, Government Central Press for publication of the same in the Tamil Nadu Government Gazette and also to the Collector of Coimbatore District under intimation to the Government.

7. The Collector of Coimbatore District is directed to report to Government the date of republication of the notification in the District Gazette.
